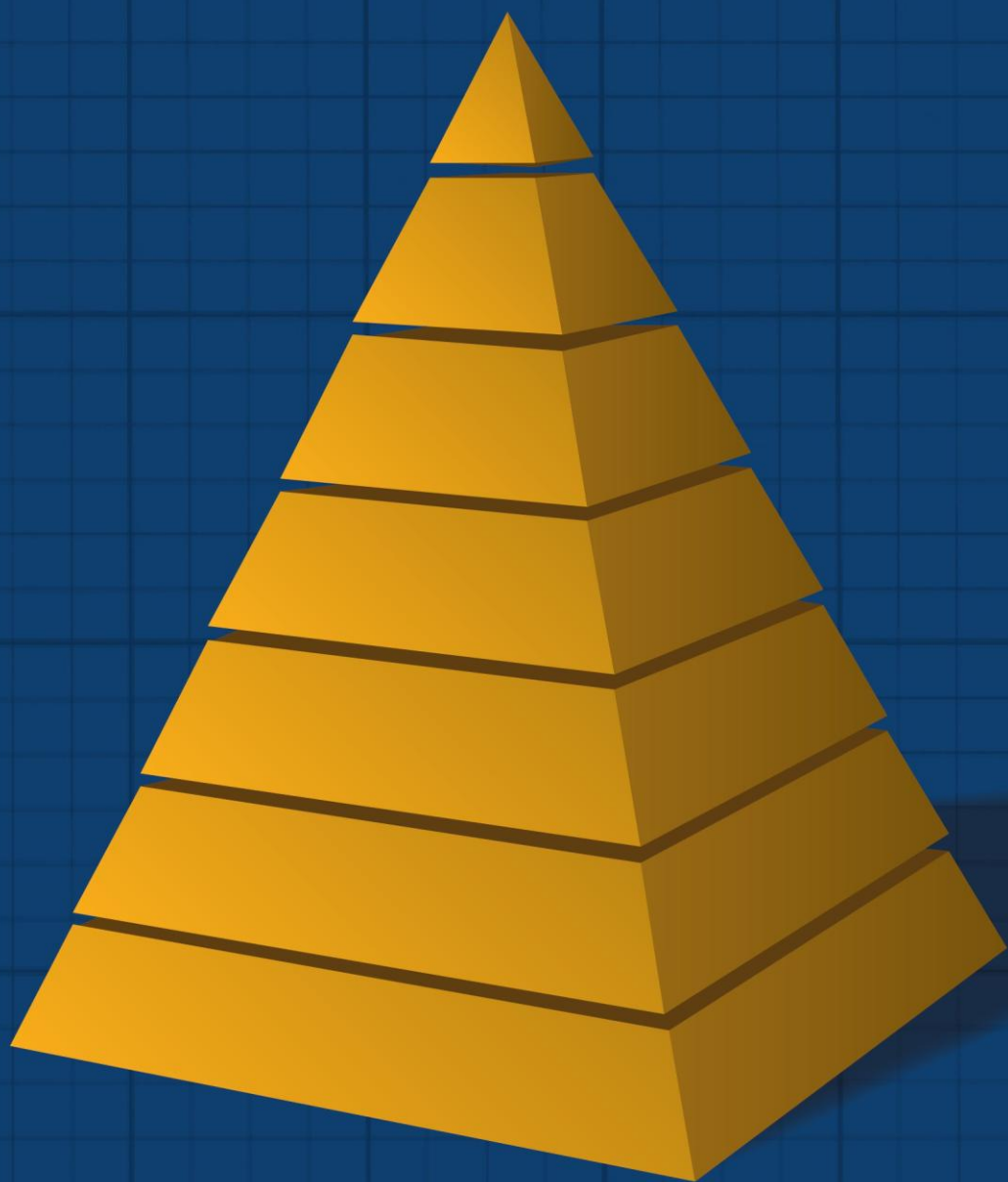

Technical View (Daily Chart)



Technical View

- ⇒ The stock is currently trading above the moving average cloud, signifying strong short-term bullish momentum and sustained interest from buyers.
- ⇒ The Stock is trading above both 20 & 50 EMA, which is a Good sign.
- ⇒ The price has decisively breached the multi-month neckline resistance, which was situated around the 1045 - 1060 zone. The strong close at 1,088 confirms this breakout.
- ⇒ It is comfortably positioned above the 50-day Exponential Moving Average (EMA), indicating ongoing medium-term strength.
- ⇒ Momentum indicator, Relative Strength Index (RSI) is above 60, which implies strength in the near term.
- ⇒ The volume expansion observed during the breakout adds credibility to this bullish setup. The price action reflects a pattern of higher highs and higher lows.
- ⇒ MACD (Moving Average Convergence Divergence): The MACD has generated a fresh bullish crossover on both the daily and weekly charts. The indicator is above the zero line, and the histogram is expanding, signaling accelerating upward momentum.
- ⇒ Based on technical, you may accumulate the stock at current levels for a possible target of 1258 and maintain a strict stop loss of 1019
